Emergency Supply Chain Coordinator: International Rescue Committee, Cox's Bazar, Bangladesh

Designed and oversaw setup of 6 simple integrated multisector team sites in 6 different refugee camps; designed and oversaw construction of 2 cyclone-resistant integrated women's centres; designed floorplan of 1 comprehensive women's centre and designed 1 cyclone-resistant primary health post in Kutupalong camp to be built by RTMI. Designed 4 nutrition stabilisation centres to be built by ACF. Negotiated free drilling of borehole with pump installation by MSF for the RTMI comprehensive women's centre.

- Pushed 7 tenders through to completion with enhanced due diligence, worth USD 835,935.00 total. Assessed Ganyiel and Nyal medical infrastructure deficiencies and developed bills of quantities for facility rehabilitation and health facility water sources, procured relevant supplies in Juba to send to the field and provided technical support to field staff overseeing rehabilitation and setup of nutrition stabilisation centres for the famine response.

- Oversaw international emergency pharmaceutical orders and cold chain equipment procurement. 2016 March – May (3 months)

Logistics Officer (P3), Rapid Response Mechanism: UNICEF, Bangui, Central African Republic

- Organised over 1.2m USD in stock releases to implementing partners, freeing up warehouse volume needed for other departments, reducing financial risks to UNICEF, preventing claw-backs from donors on expiring grants, and enabling implementing partner organisations to react to crises quickly.
- Increased and improved communication between Rapid Response Mechanism (RRM) and Supply Section, and between RRM and implementing partners, which resulted in fewer errors and more client satisfaction.

- All furniture and signage made at Kailahun EMC workshop to send to the new MSF EMC being set up in Magburaka.
- Provided technical support to the on-site laboratory of the Public Health Agency of Canada's Microbiological Emergency Response Team (MERT) in Kailahun; all furniture for Magburaka MERT lab made in Kailahun workshop.
